Please attach a recent passport photo to the form in the space provided. We need your photo to create your electronic health card.

Please also include your telephone number on the sheet. Thank you very much.

Notes on the photo:

Please send us a clearly recognisable photograph of your face, like for passport photos for identity papers. A biometric photo is not required. For example, a photo from a passport photo machine cabin is sufficient. Please note that we cannot reimburse the cost of the photo. The electronic health card is of course free of charge for our insured persons.



D. Confirmation of the identity of the person

Hints for a correct photo

- The requirements that apply are same as for photos for identity documents.
- Please use a recent colour photo.
- The background must not show any disturbing objects and must contrast clearly with the face and hair.
- Your face must be fully recognisable also if a head covering is worn for religious reasons (religious community, Christian order).
- The eyes must be open and clearly visible (for spectacle wearers, the eyes must not be covered by the spectacle frame).
- We ask for your understanding that we cannot return your picture to you.
- You can also submit your picture online. You will find the link on the back page.
